- 7. This agreement shall continue from month to month until terminated by either party. Either party may terminate the Agreement with or without cause by giving thirty days written notice to the other party.
- 8. User shall take all necessary and appropriate security measures to insure that the assigned user name and password are not disclosed to other persons or entities. User shall not share, loan, assign, transfer, or release its user name or password to any other person or entity.
- 9. User represents that the undersigned has the authority to enter this Agreement.
- In the event that it becomes necessary to file suit to enforce the terms of the Agreement, including but not limited to payment, Recorder shall be entitled to recover all costs of collection including court costs, attorney's fees and interest at the statutory rate on all amounts due and payable.
- 11. In the event that it becomes necessary to file suit to enforce any term of the Agreement, the Madison County Circuit or Superior Court shall have jurisdiction and venue of the matter. The laws of the State of Indiana shall apply to any and all disputes arising from this Agreement.
