#### **Overview**

Madison County is taking the necessary steps to ensure that the County acts in a timely, responsible manner to maximum the benefits of the American Rescue Plan Act (ARPA) assistance. The process will involve engaging County officials, County employees, community representatives, and residents.

These plans have been formulated to enable the County to make strategic use of ARPA funds to ensure alignment the needs and priorities of the County and the community.

# **Leadership Team**

The County has established a Leadership Team comprised of County officials to oversee and guide implementation of the ARPA funds. The Leadership Team includes:

# **Leadership Team Responsibilities**

- 1. Identify funding opportunities contained in ARPA, including:
  - Direct assistance to Madison County (\$26 million)
  - Collaborative opportunities with other communities
  - Other funding opportunities in ARPA
- 2. Track ARPA developments on spending requirements, allowable uses, and reporting uses
- 3. Develop and implement a strategic funding plan that identifies community priorities and aligns with eligible uses for ARPA
- 4. Receive proposals from stakeholders and ensure clarity and completeness
- 5. Facilitate discussions about proposals received and solicit feedback from pertinent stakeholders, as needed
- 6. Score proposals and identified recommendations to the County Commissioners and County Council for advancement
- 7. Support efforts to seek community engagement and input on ARPA priorities

# **Community Engagement Team**

# **Community Engagement Team Responsibilities**

- 1. Lead efforts to seek community engagement and input on ARPA priorities
- 2. Facilitate execution of the Community Engagement Plan
- 3. Continually review the Community Engagement Plan for alignment with the goals and objectives and update the plan as needed
- 4. Monitor, track, and report progress of the Community Engagement Plan
- 5. Support stakeholders in developing and submitting proposals
- 6. Serve as a liaison between the Leadership Team, community stakeholder groups, and the community

# **County Priority Areas**

County leadership has identified the following priorities for utilizing the ARPA funding:

- To support recovery from the impacts of the COVID-19 pandemic and build resiliency for responding to future pandemics
- To increase the accessibility of the County government while improving the services provided to constituents and stakeholders in the community, particularly those groups most impacted by the COVID-19 pandemic
- To facilitate transformational changes in the County by improving the environment, promoting economic viability, addressing aging infrastructure, and increasing the overall quality of life in Madison County

# Plan Implementation

The Leadership Team and the Community Engagement Team will collaborate to implement the Fund Allocation and Community Engagement Plans. These plans are detailed, below.

#### ARPA FUND ALLOCATION PLAN

#### **Overview**

The purpose of the ARPA Fund Allocation Plan is to outline the County's procedures for strategically appropriating the ARPA allocations. The Leadership Team is responsible for overseeing the fund allocation process.

## **Proposal Eligibility**

To be eligible for consideration, a proposal must be submitted by at least two eligible champions. Proposal champions can be an elected official or department head working for Madison County or a resident of Madison County representing a municipality, community group, not-for-profit organization, or other similar entity located primarily within the County. Proposals should meet one or more of the following criteria:

- Support for public health expenditures by funding COVID-19 mitigation efforts, such as medical expenses, medical supplies, telemedicine, behavioral healthcare, and specific public health and safety staff.
- Address negative economic impacts caused by the public health emergency, including
  economic harms to workers, households, small businesses, impacted industries, and the
  public sector.
- Invest in water, sewer, and broadband infrastructure, making necessary investments to improve access to clean drinking water, support vital wastewater and stormwater infrastructure, and expand access to broadband internet.
- Provide equity-based services to a population that has been disproportionately impacted by the COVID-19 public health emergency.

# **Proposals**

To be considered for ARPA funding, a proposal must be submitted to the Leadership Team for review and consideration. Proposals should contain the following general information:

- Name of proposed project
- Name and contact information for proposal point of contact
- Proposed funding plan
- Project description and explanation of how it aligns with the intent of the ARPA program
- Confirmation of eligibility for the ARPA program funds
- Proposal outcomes and impacts

## **Proposal Scoring**

The Leadership Team will score proposals on a regular basis using the following scoring matrix:

To be considered for ARPA funding, proposals must receive a minimum average score of 80 from the Leadership Team. The Leadership team reserves the right to request additional information regarding submitted proposals, as needed.

# **Appropriation Priorities**

Through the Local Recovery Act, the County has been awarded approximately \$26 million. The proposed allocation breakdown is as follows:

- Pandemic recovery/public health expenditures This includes expenditures incurred
  that can directly be attributed to the COVID 19 pandemic as well as efforts to improve
  resiliency in anticipation of future pandemic events. Additionally, this would include
  addressing negative economic impacts caused by the public health emergency.
   Targeted Allocation \$6 million
- Infrastructure Investment Eligible infrastructure investment can be made into water, wastewater, stormwater, and broadband internet services. Targeted Allocation – \$5 million
- Expansion of equity-based services Knowing that certain population segments have been disproportionately impacted by the COVID-19 pandemic, the County has designated a portion of these funds to support groups that have been historically underserved, marginalized, or adversely affected by persistent poverty and inequality.
   Targeted Allocation – \$5 million
- Lost Revenue The County has claimed the eligible \$10 million of "lost revenue." While these funds can be used for a variety of efforts, the County has stated that the overreaching objective for the "Lost Revenue" funds is to make impactful changes in the

County needed to improve the quality of life for residents and to facilitate economic growth and redevelopment. *Claimed Allocation – \$10 million* 

The Leadership team will determine the actual allocations through the proposal review/approval process.

# **Funding Approval**

Proposals selected for advancement by the Leadership Team will be presented to the County Commissioners for adoption into the ARPA Fiscal Plan. A majority vote of the County Commissioners is required for the proposal to be approved.

Once a proposal has been adopted into the ARPA Fiscal Plan, it will be presented to the County Council. A majority vote from the Council is required to approve the ARPA Appropriation for the Proposal.

#### **Fund Disbursement**

Once a proposal has been adopted into the ARPA Fiscal Plan and an ARPA Appropriation has been approved, the proposal may proceed. All applicable local, state, and federal procurement laws must be followed. Disbursement of funds must be approved by the County Commissioners office or proxy.

### COMMUNITY ENGAGEMENT PLAN

# **Objective**

The purpose of the Community Engagement Plan is to outline the County's approach for strategically engaging stakeholders through the community to encourage and facilitate involvement in the ARPA Allocation Process.

Community Engagement Plan is meant to be living document. Using this document as a starting point, the Community Engagement Team will regularly update the plan throughout the ARPA process. Engagement activities and findings will be reported to the Leadership Team, and progress reports will be shared on the County's ARPA website.

# **Community Engagement Objectives**

Through the Community Engagement Plan, the County will strive to:

- Inform the community about opportunities through the ARPA program
- Obtain feedback on priorities and needs within the community, giving a voice to traditionally underrepresented and disadvantaged populations
- Partner with stakeholders and community groups to leverage opportunities and collaborate

## **Community Partners**

The County recognizes that collaboration with community partners is critical to successful implementation of the ARPA Allocation and Engagement Plans. Once formed, the Community Engagement Team will meet to discuss the team composition and identify additional members for consideration. Additional members will be added with consensus from the team.

The team will also work to identify key audiences within the community and tailor tools as needed to maximize engagement.

# **Engagement Tools**

The County will utilize a variety of tools theroughout the Community Engagement effort . These tools will use a combination of in-person, online, and remote engagement strategies. Tools will be targeted to engage specific audiences and stakeholders. Additionally, information will be extrapolated from similar community engagement efforts and used to complement these efforts.
