**ORDINANCE AMENDING ORDINANCE NO.
2011-BC-13 DESIGNATING COUNCIL DISTRICTS
WITHIN THE COUNTY OF MADISON, INDIANA**

WHEREAS, the Board of Commissioners of Madison County, Indiana, did unanimously on the 20th day of December, 2011, approve an ordinance defining the County Council Districts as required by *Indiana Code §36-2-3-4*; and

WHEREAS, inadvertently certain population information used in the reprecincting and defining the council districts was considered in the configuration of the districts and

WHEREAS THE Board of Commissioners of Madison County, Indiana desires to amend said ordinance by way of precincts to be contained within each County Council district based upon said corrected reprecincting and census data

NOW, THEREFORE, BE IT ORDAINED by the Board of Commissioners of the County of Madison, Indiana, as follows:
